REFERRED AND INITIATED CONSTITUTIONAL AMENDMENTS AND LAWS

BALLOT ISSUES AND QUESTIONS

AMENDMENT 11

Shall there be an amendment to the Colorado Constitution concerning property tax exemptions, and, in connection therewith, eliminating any property tax exemptions for real property used for religious purposes, real property used for for-profit schools, real property used for charitable purposes other than for community corrections facilities, orphanages, or for housing low-income elderly, disabled, homeless, or abused persons, and real property used for nonprofit cemeteries; continuing the property tax exemptions for real property used for nonprofit schools, community corrections facilities, orphanages, and housing low-income elderly, disabled, homeless, or abused persons, unless otherwise provided by general law; continuing the property tax exemptions for personal property used for religious worship or strictly charitable purposes, unless otherwise provided by general law; and decreasing the property tax rate to prevent a net revenue gain to any taxing entity as a result of the elimination of exemptions, unless otherwise provided by general law?

ENMIENDA 11

¿Deberá aprobarse una enmienda a la Constitución de Colorado con respecto a las exenciones de impuestos inmobiliarios y, en relación con las mismas, para eliminar cualesquier exenciones de impuestos inmobiliarios sobre bienes inmuebles usados a fines religiosos, bienes inmuebles usados para escuelas a fines de lucro, bienes inmuebles usados para fines caritativos, excepto por instalaciones correccionales u orfanatos, o para albergar personas de escasos recursos mayores, incapacitadas, desamparadas o abusadas y bienes inmuebles usados para cementerios sin fines de lucro; para continuar las exenciones de impuestos inmobiliarios sobre bienes inmuebles usados para escuelas sin fines de lucro, instalaciones correccionales comunitarias, orfanatos o para albergar personas de escasos recursos mayores, incapacitadas, desamparadas o abusadas, salvo que se estipulare de otra manera en la legislación general; para continuar las exenciones de impuestos inmobiliarios sobre bienes muebles usados a fines religiosos o fines estrictamente caritativos, salvo que se estipulare de otra manera en la legislación general; y para disminuir la tasa de impuestos inmobiliarios a fin de impedir un aumento de ingresos netos para cualquier entidad tributaria como resultado de la eliminación de las exenciones, salvo que se estipulare de otra manera en la legislación general?

REFERRED AND INITIATED CONSTITUTIONAL AMENDMENTS AND LAWS

AMENDMENT 12

Shall there be an amendment to the Colorado Constitution concerning congressional term limits, and, in connection therewith, specifying a proposed amendment to the U.S. Constitution that limits U.S. Senators to two terms, former and incumbent U.S. Senators to one additional term, U.S. Representatives to three terms and former and incumbent U.S. Representatives to two additional terms; instructing Colorado's State Senators and Representatives to vote to apply for an amendment-proposing convention; instructing Colorado's U.S. Senators and Representatives to pass said term limits amendment; requiring that all election ballots have "Disregarded Voter Instruction On Term Limits" next to the name of an incumbent U.S. Senator or Representative or incumbent state senator or representative when such senator or representative fails to take specific actions in support of said term limits amendment; providing that non-incumbent candidates for U.S. and state senator and representative be given an opportunity to take a pledge in support of said term limits amendment; requiring that primary and general election ballots have "Declined To Take Pledge To Support Term Limits" next to the name of a non-incumbent candidate who has not signed such pledge; authorizing the secretary of state to determine whether the terms of this amendment have been complied with and whether such designations should appear on the ballot; and allowing any legal challenge to this amendment to be filed with the supreme court of Colorado as an original action?

ENMIENDA 12

¿Deberá aprobarse una enmienda a la Constitución de Colorado con respecto a límites de términos congresionales y, en relación con la misma, para especificar una enmienda propuesta a la Constitución de EE.UU., que limita los Senadores de EE.UU., a dos términos, los antiguos Senadores y Senadores en funciones a un término adicional, los Representantes de EE.UU., a tres términos y los antiguos Representantes y Representantes en funciones a dos términos adicionales; para ordenar a los Senadores y Representantes Estatales de Colorado a votar a favor de solicitar una convención para la propuesta de enmiendas; para ordenar a los Senadores y Representantes de EE.UU. de Colorado que promulguen dicha enmienda de límites de términos; para exigir que todas las balotas electorales lleven la leyenda "Ignoró la instrucción de los votantes sobre límites de términos" al lado del nombre de un Senador o Representante de EE.UU. en funciones o senador o representante estatal en funciones cuando dicho senador o representante no tomare medidas específicas en apoyo de dicha enmienda de límites de términos; estipulándose que los candidatos no en funciones a los cargos de senador y representante de EE.UU., y estatal tengan la oportunidad de hacer una promesa en apoyo de dicha enmienda de límites de términos; para exigir que las balotas electorales primarias y generales lleven la leyenda "No aceptó la promesa de apoyar los límites de términos" al lado del nombre de un candidato no en funciones que no hubiere firmado tal promesa; para autorizar al secretario de estado que determine si se han cumplido los términos de la presente enmienda y si dichas designaciones deberán aparecer en la balota; y para permitir que se entable cualquier impugnación legal contra esta enmienda ante la corte suprema de Colorado como acción original?

REFERRED AND INITIATED CONSTITUTIONAL AMENDMENTS AND LAWS

AMENDMENT 13

Shall there be an amendment to the Colorado Constitution concerning petitions, and, in connection therewith, changing initiative and referendum rights and procedures; extending petition powers to registered voters of all local governments; limiting initiative ballot titles to 100 words; limiting the annual number of newly enacted laws that governments may exclude from possible referendum petitions; establishing standards for review of filed petitions; requiring voter approval for future petition laws and rules and for changes to certain future voter-approved petitions; and authorizing lawsuits to enforce the amendment?

ENMIENDA 13

¿Deberá aprobarse una enmienda a la Constitución de Colorado con respecto a las peticiones y, en relación con las mismas, para cambiar los derechos y procedimientos de iniciativa y referéndum; para extender las facultades de petición a los votantes registrados de todos los gobiernos municipales; para limitar los títulos de balota de iniciativa a 100 palabras; para limitar el número anual de leyes nuevas promulgadas que los gobiernos podrán excluir de posibles peticiones por referéndum; para establecer normas con respecto a la revisión de las peticiones entabladas; para exigir la aprobación de los votantes de leyes y reglas de petición futuras y de cambios a ciertas peticiones futuras aprobadas por los votantes; y para autorizar acciones legales a fin de hacer cumplir la enmienda?

REFERRED AND INITIATED CONSTITUTIONAL AMENDMENTS AND LAWS

AMENDMENT 14

Shall there be an amendment to the Colorado Constitution concerning prohibited methods of taking wildlife, and, in connection therewith, prohibiting the use of leghold traps, instant kill body-gripping design traps, poisons, or snares; providing an exception for the use of such methods by certain governmental entities for the purpose of protecting human health or safety or managing fish or other non-mammalian wildlife; providing an exception for the use of such methods to control birds or to control rodents other than beaver and muskrat, as otherwise authorized by law; providing an exception for the use of such methods on private property, under certain conditions, to reduce damage to crops or livestock; providing an exception for the use of certain non-lethal snares, traps, or nets to take wildlife for purposes of scientific research, falconry, relocation, or medical treatment under rules of the Colorado Wildlife Commission; providing that the measure shall not apply to the taking of wildlife with firearms, fishing equipment, archery equipment, or other implements in hand as authorized by law; incorporating the current statutory definitions of the terms "taking" and "wildlife"; and requiring the general assembly to enact implementing legislation by May 1, 1997?

ENMIENDA 14

¿Deberá aprobarse una enmienda a la constitución de Colorado con respecto a la prohibición de métodos de cazar la fauna natural, y en relación con la misma, para prohibir el uso de trampas sujetapata, trampas sujetacuerpo que matan instantáneamente o mediante el uso de veneno o trampa; para estipular una excepción al uso de estos métodos por parte de ciertas entidades gubernamentales con los fines de proteger la salud o seguridad del ser humano o para la administración de los peces y otra fauna no mamífera; para estipular una excepción al uso de dichos métodos para el control de las aves o para el control de los roedores que no sean los castores o ratas almizcleras, según sea estipulada de otra manera por ley; para estipular una excepción al uso de dichos métodos en propiedades privadas, bajo ciertas condiciones, a fin de reducir los daños a las cosechas o la ganadería; para estipular una excepción al uso de ciertas trampas dispositivos o redes no letales para la caza de la fauna natural a fines de investigación científica, cetrería, reubicación o tratamiento médico bajo las reglas de la Comisión de la Fauna Natural de Colorado; para estipular que la medida no se aplicará a la caza de la fauna natural con armas de fuego, equipos de pesca, equipos de tiro y otros implementos de mano, según sean autorizados por ley; para incorporar las definiciones estatutarias actuales de los términos "caza" y "fauna natural"; y para exigir que la asamblea general promulgue la legislación de implementación antes del 1º de mayo de 1997?

AMENDMENT 15

Shall there be an amendment to the Colorado Revised Statutes concerning campaign reform, and, in connection therewith, limiting the amount of campaign contributions to candidate committees, political committees, and political parties; prohibiting candidate committees and political parties from making or accepting certain contributions; specifying who may contribute to a candidate committee; limiting the amount of unexpended campaign contributions that a candidate committee can carry over from one campaign to another campaign; creating voluntary campaign spending limits and attendant disclosure requirements; and reenacting, with amendments, current campaign reform law definitions and provisions regarding deposits of contributions, limits on cash contributions and expenditures, the prohibition on contribution reimbursement, uses of unexpended contributions, notice and disclosure of independent expenditures, reporting of contributions and expenditures, registration requirements for candidates and committees, civil and criminal sanctions and penalties, expenditures for political advertising, encouraging withdrawal from a campaign, home rule counties and municipalities, and contribution limits on state and political subdivisions and on lobbyists?

ENMIENDA 15

¿Deberá aprobarse una enmienda a los Estatutos Revisados de Colorado con relación a la reforma de campañas políticas y, en relación con la misma, para limitar el importe de las contribuciones de campaña a los comités de candidatura, comités políticos y partidos políticos; para prohibir que los comités de candidatura y partidos políticos hagan o acepten ciertas contribuciones; para especificar quiénes podrán contribuir a un comité de candidatura; para limitar el importe de las contribuciones de campaña sin gastar que un comité de candidatura podrá trasladar de una campaña a otra; para crear límites voluntarios de gastos de campaña y requisitos de divulgación consonantes; y para repromulgar con enmiendas, las definiciones y estipulaciones de la ley de reforma de campañas actual con respecto al depósito de las contribuciones, los límites sobre contribuciones y gastos en efectivo, la prohibición del reembolso de las contribuciones, los usos de las contribuciones sin gastar, el aviso y divulgación de gastos independientes, la declaración de contribuciones y gastos, requisitos de registro de candidatos y comités, sanciones y multas civiles y penales, gastos de publicidad política, actividades para alentar el retiro de una campaña, condados y municipalidades autónomos y límites de contribución sobre subdivisiones estatales y políticas y sobre cabilderos?

REFERRED AND INITIATED CONSTITUTIONAL AMENDMENTS AND LAWS

AMENDMENT 16

Shall there be an amendment to the Colorado Constitution concerning the management of state assets related to the public lands of the state held in trust, and, in connection therewith, providing that the board shall serve as the trustee for the lands granted to or held by the state in public trust; adding to the board's duties the prudent management and exchange of lands held by the board; requiring the board to manage lands held by the board in order to produce reasonable and consistent income over time, and to recognize that economic productivity and sound stewardship of such lands includes protecting and enhancing the beauty, natural values, open space, and wildlife habitat thereof; providing for the establishment of a long-term stewardship trust of up to 300,000 acres of land; requiring the board to take other actions to protect the long-term productivity and sound stewardship of the lands held by the board, including incentives in agricultural leases which promote sound stewardship and sales or leases of conservation easements; authorizing the board to undertake non-simultaneous exchanges of land; authorizing the general assembly to adopt laws whereby the assets of the school fund may be used to assist public schools to provide necessary buildings, land, and equipment; providing opportunities for school districts in which lands held by the board are located to lease, purchase, or otherwise use such lands for school building sites; requiring the board, prior to a land transaction for development purposes, to determine that the income from the transaction will exceed the fiscal impact of the development on local school districts; allowing access by public schools for outdoor education purposes without charge; expanding the state board of land commissioners to five members and requiring a diversity of experience and occupation on the board; reducing the terms of office of the members of the board to four years; directing the board to hire a director and a staff; and providing for personal immunity of the individual board members from liability in certain situations?

ENMIENDA 16

¿Deberá aprobarse una enmienda a la Constitución de Colorado con respecto a la administración de los bienes estatales relacionados con las tierras públicas del estado tenidas en fideicomiso y, en relación con la misma, para estipular que la junta fungirá como fiduciario de las tierras concedidas a, a tenidas por el estado en fideicomiso público; para incluir en los deberes de la junta la administración y permuta prudente de tierras tenidas por la junta; para exigir que la junta administre las tierras tenidas por la misma con el fin de generar ingresos razonables y constantes con el tiempo y que reconozca que la productividad económica y administración prudente de dichas tierras incluyen la protección y renovación de la belleza, valores naturales, espacios abiertos y hábitats de fauna natural de las mismas; para estipular el establecimiento de un fideicomiso administrativo a largo plazo de hasta 300,000 acres de tierra; para exigir que la junta tome otras medidas a fin de proteger la productividad a largo plazo y administración prudente de las tierras tenidas por dicha junta, incluso incentivos en arriendos agrícolas que promuevan una administración prudente y ventas o arriendos de servidumbres de conservación; para autorizar a la junta que emprenda permutas no simultáneas de tierra; para autorizar a la asamblea general que adopte leyes bajo las cuales podrán usarse los bienes del fondo escolar para ayudar a las escuelas públicas a proporcionar los edificios, terrenos y equipos necesarios; para ofrecer a los distritos escolares situados en dichas tierras la oportunidad de arrendar, adquirir o de otra de otra manera aprovecharlas para fines de sitios de edificios escolares; para exigir que, antes de una transacción de tierras a fines de urbanización, la junta determine que los ingresos derivados de la transacción excederán el impacto fiscal de la urbanización en el distrito escolar local; para permitir el acceso

a las escuelas públicas a fines de educación al aire libre sin cargo; para ampliar la junta estatal de comisionados de tierras a cinco miembros y exigir una diversidad de experiencia y profesiones en la junta; para reducir a cuatro años los términos de servicio de los miembros de la junta; para ordenar a la junta que contrate un director y un personal; y para estipular la inmunidad personal de los miembros individuales de la junta contra responsabilidad bajo ciertas situaciones?"

AMENDMENT 17

Shall there be an amendment to the Colorado Constitution concerning parental rights, and, in connection therewith, specifying that parents have the right to direct and control the upbringing, education, values, and discipline of their children?

ENMIENDA 17

¿Deberá aprobarse una enmienda a la Constitución de Colorado con respecto a los derechos de los padres y, en relación con la misma, para especificar que los padres tienen el derecho de dirigir y controlar la crianza, educación, los valores y disciplina de sus hijos?

AMENDMENT 18

Shall there be an amendment to the Colorado Constitution to permit limited gaming, subject to a future local vote, in original or reconstructed historic buildings in the national historic district of the city of Trinidad and to allocate tax and fee revenues from such limited gaming?

ENMIENDA 18

¿Deberá aprobarse una enmienda a la Constitución de Colorado para permitir los juegos de azar restringidos, con sujeción a un voto local futuro, en edificios históricos originales o reconstruidos en el distrito histórico nacional de la ciudad de Trinidad y para asignar ingresos tributarios y de honorarios de dichos juegos de azar restringidos?

REFERRED AND INITIATED CONSTITUTIONAL AMENDMENTS AND LAWS

REFERENDUM A

"An amendment to articles V and XIX of the constitution of the state of Colorado, concerning ballot measures, and, in connection therewith, requiring voter approval of proposed constitutional amendments by sixty percent of the votes cast thereon, permitting, until January 1, 2003, a simple majority of votes to approve amendments to amend or repeal any provision that was previously adopted with less than sixty percent of the votes cast thereon, prohibiting the general assembly from amending or repealing any law enacted by the initiative within four years of adoption unless approved by two-thirds of all the members elected to each house of the general assembly, and requiring that initiated and referred measures to amend the constitution be submitted to the electors at a general election and not at an election held in an odd-numbered year."

REFERÉNDUM A

"An amendment to article XIV of the constitution of the state of Colorado, concerning the office of county sheriff, and, in connection therewith, authorizing the general assembly to establish qualifications for the office of county sheriff."

REFERENDUM D

"An amendment to section 20 of article X of the constitution of the state of Colorado, concerning the exclusion of funds for unemployment compensation from fiscal limitations, and, in connection therewith, modifying the definition of "Fiscal Year Spending" to exclude unemployment compensation funds, excluding actions relating to charges imposed to fund unemployment compensation from the voter-approval requirement for tax increases, and requiring a one-time reduction in district bases to exclude a portion of a district's fiscal year spending from unemployment compensation funds."

REFERÉNDUM D
