The 1982 Abstract of Vote canvassed in December, 1982 by Mary Estill Buchanan, Secretary of State, has again been produced by computer. All county canvass of vote reports are checked for accuracy of total votes for each office and compared to the number of voters receiving a ballot (poll book count). Errors and discrepancies are returned to County Canvass Boards for correction.

Once all totals are correct, the computer processes the registration totals for the election, determines the number of persons not voting on that office, and computes the percentage registered but not voting.

Added in this 1982 publication is the analysis of registered voters casting a ballot (voter turnout). This feature is added to the "no" vote included in abstracts since 1976. With this addition, the published Abstract of Vote becomes a complete research document for the 1982 primary and general elections.

Since 1982 was also the first state-wide election conducted after reapportionment of congressional and legislative districts, other changes have been made in format. State Senate incumbents not on the ballot in 1982 are shown by the district number from which they were elected in 1980 with the new district in which they reside listed in parenthesis ().

The final change in the 1982 publication is in the Directory of Officials section. Since publication is several months after the canvass of votes which determines winners and losers, the Directory has been updated. It includes replacement appointments for persons elected to office who have failed to take the oath of office or who have resigned or died during their term of office.

The Sixth Congressional District Vacancy Election canvass of votes (March 27, 1983) is added as a supplement.

My goal is to provide accurate and complete canvass of vote totals, the resultant analysis of voter turnout and failure to vote for a special office or offices, and an updated Directory.

Your comments are appreciated as we continue to evaluate this publication.

SUBMITTING TO THE REGISTERED ELECTORS OF THE STATE OF COLORADO THE QUESTION SHALL SECTIONS 3 AND 4 OF ARTICLE X OF THE COLORADO CONSTITUTION BE AMENDED IN THE FOLLOWING MANNER IN REGARDING ACTUAL VALUE AND VALUATION FOR ASSESSMENT TO REDUCE THE VALUATION FOR ASSESSMENT OF RESIDENTIAL REAL PROPERTY CONSISTING OF ALL RESIDENTIAL DWELLING UNITS AND UNIMPROVED LAND AND MOBILE HOME PARKS, BUT EXCLUDING HOTELS AND MOTELS FROM THIRTY TO TWENTY PERCENT OF THE ACTUAL VALUE TO REQUIRE THE GENERAL ASSEMBLY TO ADJUST SUCH PERCENT FOR YEARS IN WHICH A NEW LEVEL OF VALUE IS USED IN DETERMINING ACTUAL VALUE AS SUCH ADJUSTMENT IS NEEDED TO MAINTAIN THE PREVIOUS YEAR'S PERCENTAGE OF STATEWIDE VALUATION FOR ASSESSMENT ATTRIBUTABLE TO RESIDENTIAL REAL PROPERTY TO REDUCE THE VALUATION FOR ASSESSMENT OF ALL OTHER TAXABLE PROPERTY FROM THIRTY TO TWENTY PERCENT TO PROVIDE THAT ACTUAL VALUE BE DETERMINED BY APPROPRIATE CONSIDERATION OF COST APPROACH MARKET APPROACH AND INCOME APPROACH TO APPRAISAL EXCEPT ACTUAL VALUE OF RESIDENTIAL REAL PROPERTY SHALL BE DETERMINED BY CONSIDERATION OF COST AND MARKET APPROACHES ONLY AND ACTUAL VALUE OF AGRICULTURAL LANDS SHALL BE DETERMINED BY CONSIDERATION OF EARNING OR PRODUCTIVE CAPACITY CAPITALIZED AT A RATE PRESCRIBED BY LAW TO PROVIDE THAT VALUATION FOR ASSESSMENT FOR PRODUCING MINES AND OIL AND GAS LEASEHOLDS AND LANDS BE A PORTION OF ACTUAL ANNUAL OR ACTUAL AVERAGE ANNUAL PRODUCTION AND BE BASED UPON THE VALUE OF THE UNPROCESSED MATERIAL. (B) REGARDING EXEMPTIONS FROM PROPERTY TAX TO EXEMPT THE FOLLOWING CLASSES OF PERSONAL PROPERTY: HOUSEHOLD FURNISHINGS, PERSONAL EFFECTS, INVENTORIES OF MERCHANDISE AND MATERIALS AND SUPPLIES HELD FOR BUSINESS CONSUMPTION OR FOR SALE OF LIVESTOCK AND LIVESTOCK PRODUCTS AND AGRICULTURAL EQUIPMENT USED ON THE FARM OR RANCH IN PRODUCING AGRICULTURAL PRODUCTS.
